A parliamentarian is still being sought, T Roark has been asked but declined as he would like to be involved in discussion.</p> <p>J Egeler – We should wait and see who attends the conference and ask someone there. C Kurzac could be a possible choice.</p> <p>K Cordner – The Parliamentarian is to oversee the proceedings. The Sergeant-at-Arms acts as security so no one leaves the meeting</p>

If so I can do it as I would like to participate.</p> <p>K Cordner – I will clarify that issue and get back.</p> <p>K Cordner – Only members with voting rights will vote. Only voting members may enter into debate. Debate is 2 minutes per person. If further debate is required that is possible. Quorum is ¾ and scrutineers will verify numbers. Appointments of positions will be done at the meeting.</p> <p>J Egeler – The parliamentarian at National meeting has clarified that reports are to be discussed but a motion to accept is not necessary.</p> <p>K Cordner – Have we followed that at past AGMs?</p> <p>J Egeler – We did not have an AGM last year as we did not reach quorum.</p> <p>K Cordner – I will introduce these parameters at the meeting.</p> <p>J Egeler – What if we just put them in written form on each table in the interest of time?</p> <p>K Cordner – Please clarify which tables.</p> <p>J Egeler – All the tables where members sit. I already have this in written format.</p> <p>K Cordner – If it is in written format we should do that.</p> <p>➤ Notice of Motions – Questions</p> <p>K Cordner – There are two Notice of Motions this year. First is Electronic Vote – we are already doing this but want to legalize it in our Constitution and Bylaws. Second is to change the role of Vice President to President Elect.</p> <p>S MacDougall – Will the current Vice President automatically go into the role of President Elect or will there be a vote?</p> <p>K Cordner – If ratified, the changes will take place immediately and the next voting will be in 2011. In the past generally positions were filled by people suggested by those currently in power. The process has much improved. This situation also brings to light things lacking within the Branch and BOC. We need to make expectations clear, because these positions are volunteered they are sometimes not taken as seriously. In the past there has been some concerns with confidentiality surrounding the BOC; we need to hold everyone accountable and speak up if we hear things.</p> <p>K Cordner – Agreed, we should get this put into the BOC Manual. If there are mumbblings of lack of confidentiality it needs to be reported.</p> <p>J Egeler – It is also good to remember that it is okay to vote against a motion. This sparks good debate and no one will hold it against you.</p> <p>K Cordner – Good point, we try to provide everyone with adequate information to make an informed decision.</p>
